Dear Fellow Oswayo Valley Hunt Club Member:

It's that time of the year for renewal of your membership in the 3070 acre lease of the Oswayo Valley Hunt Club. Hopefully all members have had a chance to enjoy the lease to some extent since January 1, 2018. The major portion of our hunting season is ahead of us, but I must prepare the necessary information to send to the Forest Investments Associates (owner of the property) including the members' name and address for the year 2019. To get this done, I will need the membership dues in my possession by **Saturday, December 22, 2018**. As always, the membership would make a great Christmas gift.

The timber company is changing the date and amount of the payment of the lease. By June 30, 2020, our agreement will be the same as all of their other leases in that memberships will be from July 1 to June 30 each year. The new membership rate will be \$350 per person per year. To get us to that schedule, they are pro-rating the amounts of the contract to cover the next 18 months.

The payment of \$350 for each member is due by December 22, 2018, and the remaining \$150 will be due by June 1, 2019. This payment schedule will cover your full membership until June 30, 2020. If you prefer to pay the entire \$500, you will have a full 18-month membership through June 30, 2020. The subsequent new due date for annual memberships will be **June 1st each year**.

The annual membership fee schedule will now be the following:

- **Full membership:** \$350 due by December 22, 2018 And \$150 due by June 1, 2019; Or \$500 due by December 22, 2018
- **ATV-Spouse with Full membership:** \$150.00
- **Family membership:** \$550.00 (includes spouse and up to 3 children under 18 yrs. of age living at home). Additional children at \$50.00 each
- **Hike/Ride membership:** \$150.00 each (No hiking or riding during turkey, deer, and bear seasons)

When sending membership fees, send exhibit B (filled in and signed) back to me as this goes to FIA. Please include your email address.

As always, I will need to submit a deer kill report (especially antlerless) to the timber company in January 2019. As a result, I must get your kill information in December after the seasons are over. For those who own property adjoining or near the lease, and you harvest a doe on your property, let me know as we have a set number to harvest each year. If you have any questions or concerns, please contact me. If no answer, leave a message. Cell phone will probably get you a quicker response.
